The aim of this module is to explore integration in relation with life course perspective and intergenerational processes. Integration concern first generation migrants and their descendants but also non- immigrant populations and it is important to clarify the uses of this concept in different contexts by different disciplines. It is also necessary to discuss through concrete examples which are the methodological possible bias and their implications for the perception of integration processes.

The main questions that will be addressed are the following: what is the meaning of integration from a life course perspective? Which are the main dimensions of integration and how can they be measured? Which processes are related to the integration of migrants and their descendants in a specific society? Which are the relations between integration and transnationalism?

The module will also take into account theoretical and methodological questions brought by the doctoral students
